#### 1. ORDER OF PRECEDENCE

In the event of an inconsistency in this order, unless otherwise provided, the inconsistency shall be resolved by giving precedence in the following order:

- A. Terms and conditions incorporated in the first and succeeding pages of Buyer's order, as amended.
- B. Terms and conditions incorporated in the A-2 Provisions for Government Contracts.
- C. Supplemental Provisions incorporated herein (N-2 Provisions for NASA Contracts)
- D. Standard ILC Dover Purchase Order terms and conditions (available at <u>www.ilcdover.com</u> under the "Terms and Conditions" link).
- E. Statement of Work

### 2. <u>NFS - NASA FEDERAL ACQUISITION REGULATION SUPPLEMENT</u> <u>CLAUSES</u>

Goods or services provided in fulfillment of this order are chargeable to a contract issued by an agency of the U.S. Government, the NASA. The NASA FAR Supplement (NFS) clauses cited below, in effect as of the date of the accompanying Purchase Order, are incorporated by reference with the same force and effect as if provided in full text.
